6. Reports:

A. ATA Quarterly Leadership Summits (QLS) - Melissa J. reported on the ATA QLS she attended (virtually) on 8/16/2022 - NMTIA shares many similarities with other local ATA groups: similar size, challenges with finding enough volunteers, many members faced and continue to face challenges due to COVID; Good ideas were shared on ways to support members, and to engage and demonstrate appreciation for volunteers.

Next QLS: October 15, 2022, in-person, at the ATA Conference in L.A. - Melissa J. requested 2 volunteers, 1 from Board, 1 not from Board - no volunteers

B. NCSC Court Interpreter Video Remote Interpretation Focus Group on August 23 - Melissa J. reported that she participated in a focus group on VRI hosted by the National Center for State Courts, for the purpose of developing training on VRI for court interpreters in California

7. Updates/Follow-Up:

A. Maintaining our 501(c)(6) Status with IRS and Status with NM Secretary of State: Tina S. reported that while she was able to successfully submit the annual report with the NM Secretary of State, online, there remains more to do: We still need to file with the IRS, and we may already be late for that, and we have 60 days to fix or complete our state filing. It may be wise to contract with a tax professional to make sure we have done this correctly and that we know how to file annual reports correctly in the future. Kari C. suggested we contact an attorney named Steven Long, who does non-profit tax consulting.

8. New Business/Upcoming Events:

- A. Greater outreach to ASL interpreters, others, such as in educational settings: Melissa J. reported that Board members Mansilla and Yris C. had proposed that NMTIA reach out to our ASL interpreter colleagues, perhaps for joint professional development, to learn together and to learn from each other. Example given of when relay interpreting is needed with both ASL and spoken-language interpreters working together. Two members expressed enthusiastic agreement with this idea, one member expressed uncertainty. The issue was left for additional discussion at a later date.
- **B. 2022** Juan José Peña Scholarship: Members were invited to apply, deadline is Nov. 1. Question: Are student members eligible to apply? Answer: Yes need for development. Question: Can the funds be used for online training? Answer: Yes, but an online conference is better than an isolated, single training.

C. Professional Development:

- We are still awaiting a reschedule date from the presenter for the presentation on Gender Neutral Language, originally scheduled in Aug.

- Volunteers were requested to help bring additional professional development events to NMTIA members.
- D. Court Interpreter Shortage Best role for NMTIA? There have been more and more reports of trials and other court settings for which it has been difficult to proceed or settings are delayed due to a shortage of certified court interpreters, and even in some cases a lack of Justice System Interpreters. Members were asked for their feedback as to the best role for NMTIA to alleviate this situation. Member responses included: 1) Inform members of this shortage and of the requirements/process for certification; 2) Ask the NM Administrative Office of the Courts (NMAOC) to offer contracts throughout the year, rather than only during a short window right before the beginning of the fiscal year (July 1); 3) Support interpreters in-training, with mentors, other ways? Question from member: Is this just a NM problem or is this nationwide? Answer: From what members have seen from national organizations, this is a problem in many states across the country.
